Registration Fee/Tuition

There is a non-refundable \$175.00 registration fee for new students. The tuition cost is spread evenly over 10 months regardless of the number of school days in the month. Tuition will be prorated for the month if the student enters after the first day of the month.

Half Month Tuition Payment

The non-refundable half-month tuition payment made to secure your child's spot may, at the ELC's discretion, be applied to the payment of the tuition due for the final month of your child's last contracted current contractual year at the ELC. In the event that you withdraw your child from the ELC prior to the conclusion of the current contractual year, the half-month tuition payment will not be refunded.

Tuition Subsidies

Families receiving tuition subsidies (including but not limited to federal, state, or private funding) remain fully responsible for all tuition and fees. In the event that a subsidy is reduced, delayed, denied, suspended or terminated for any reason, the parent/guardian agrees to be personally and financially responsible for the full balance due. Payments of tuition are not contingent upon receipt of subsidy funds.

Late Fee

Tuition is due on the 1st of each month. A 10% late fee will be added to your balance if payments are not received by the 5th of the month. Your child will not be able to attend beyond the end of the month unless your balance is current.

Closures/Holidays, Early Closures, and Professional Development Days

Closures

There is no deduction in tuition for closures beyond the Center's control including but not limited to inclement weather, power disruptions, business continuity crisis, temporary travel, or other restrictions established by a government authority.

Late Pick-Up Charges

Parents must pick up their children at the end of their program or another designated time, if applicable. If a parent is late, a fee will be charged based on this scale: **up to fifteen minutes = \$15, sixteen to thirty minutes = \$30, thirty to forty-five minutes = \$45, forty-six minutes to 1 hour = \$60.** The late fee must be paid in the administration office on the same day it occurs. Please remember that the center closes at 6 pm. All children must be picked up, and families must exit the facility by that time.

Tuition Subsidies

Families receiving tuition assistance through a subsidy provider remain ultimately responsible for full tuition payment. If a subsidy is reduced, suspended, denied, delayed, or becomes delinquent for any reason, the parent/guardian is responsible for any remaining balance on the account. All outstanding balances must be paid in full by the end of the contractual year.
